Rules & Regulations

1. Contestants must be at least 21 years of age prior to the date of the contest.
2. Judging will be based on a total point accumulated system. Ties will be broken by the answering of a question by the persons involved.
3. Contestants will be judged in the following categories: Presentation, please provide a short bio about presentation, Talent (10 minutes max), Formal/Evening Wear (please provide a descriptive detail of formal/evening wear to MC the night of the contest), and On Stage Question & Answer.
4. Talent presentations will be limited to 10 minutes. All talent presentations must be on CD (audio format, no digital) labeled with your name, contestant number, and the title of your talent presentation. Any talent presentation is acceptable except those presentations that may be deemed illegal or those that might cause injury to the audience or to other contestants. Nudity and pyrotechnics are not allowed, **NO FIRE WHATSOEVER!**
5. Any contestant whose actions are interpreted as demeaning to the title of Mr. & Miss Tony's Corner Pocket 2017 will be disqualified.
6. All contestants are requested to do a minimum of three fundraisers at Tony's Corner Pocket, the first of the three will be for PWA Holiday Charities: (www.pwaholidaycharities.org), a *501(c)(3) non-profit organization*. The remaining two fundraisers can be for the charity of their choice. The winners will represent Tony's Corner Pocket by performing at the Annual 4th of July Show, Bar Anniversary Show, and Christmas Show. If asked by Tony Vaccaro, the owner of Tony's Corner Pocket, winning contestants agree to participate in other fund-raising events representing Tony's Corner Pocket. If the winning contestant is unable to do the minimum of three fundraisers as requested, or represent Tony's Corner Pocket by agreeing to perform in bar shows listed above, they may be subject to relinquish the title.
